HUD recently updated the Documentation Sources for Environmental Reviews. The updated documentation is for use by local SC local governments completing environmental reviews in accordance with 24 CFR Part 58. The information has been formatted for compatibility with the current suggested Environmental Assessment format; however, applicable information from the sheet may also be used to complete Statutory Worksheets. Please review all referenced processes and documents in detail to ensure full compliance on all Environmental Review records (ERR). This is effective immediately for all projects which have not received a Notice of Removal of Environmental Conditions.

The new Documentation Sources document includes the following changes:

- General Item The link to the HUD environmental website has been updated.
- Historic Preservation The contact information for the Catawba Indian Nation Tribal Historic Preservation Officer has been updated, and the link for the SHPO project review form has been updated.
- Floodplain Management Information has been added to address required notification of FEMA during completion of the 8-step process.
- Endangered Species The contact information for the Charleston Field Office has been updated.
- Noise Abatement and Control The guidance has been modified to reflect current HUD guidance regarding major highways (There is no longer a minimum AADT for major highways. Major highways are now all roads that serve as collectors) and the link for obtaining AADT information has been updated.
- Airport Runway Clearzone or Clear Zone Disclosure a link has been added for acquisition of a sample Clearzone Disclosure Notice.
